Re commencement of practical training in institute campus from 01.06.2021, subject to lifting of curfew orders by the Govt. of NCT Delhi from 31.05.2021

Trust all are safe with your family, friend near and dears. We have just passed through a tuff time bearing the 2nd wave of pandemic covid 19. Understand the difficulties faced by one and all. The imposing a month of curfew/lockdown by the Govt. of NCT Delhi steered us to directed you all at a course to home. The GP Rating class 1 and 1st 1/3 of DNS cadet however could attend about 20days practical training during the month of April 2021 prior to announcement/implement of curfew.

As the situation is improving and we foresee that the Govt. of NCT Delhi may remove the present restriction/ curfew on 31.05.2021. The institute has to conduct the training as per the very best directives and guidelines of the DG Shipping, Ministry of Ports and Shipping. All approved course has to be streamlined so as to ensure the timely completion of training, assessment and certification. Soon the orders if issued by the Govt. of NCT Delhi, these order shall come into force ensuring proper implement of SoPs issued by the DGS and Govt. of NCT Delhi. We shall be re calling very few /required faculty and instructors for the practical training ensuring the social distancing, wearing of masks, washing of hands and sanitizing of man, material, equipment offices and accommodation including messes and dining hall.

Requirement of RT PCR Test: Students as mentioned below shall undergo the RT PCR Test before reporting for practical training so as they are in possession of a negative covid RT PCR test approved by ICMR performed within 72 hours of joining institute. Antigen report shall not be accepted. The duty instructor/warden shall be receiving students in his office along with declaration form and a letter from their parents confirming their agreement to attend training in institute's campus and his ward shall abide by all covid rules/protocol. Students fall's under reporting in 1st group viz on 01.06.2021 can opt for RT PCR test from 29.05.2021 and onwards

All students as per the schedule shall reach institute for Practical training/ external examination if situation remain as usual/normal. The process of re-opening/recalling of the students shall be as under:
