Presently the GP 2 course (05/2021) has been undergoing Practical phase of GP Rating course and shall depart to home on 23.09.2021 for Online & Basic Safety Training Classes.

This institute shall have to keep only 1/3 strength of sanctioned intake of students at all times in campus till any fresh order on subject is issued by the Directorate General of Shipping.

This is to note that all students of Pre Sea GP Rating course Class GP3 (06/2021) shall be reporting for the practical training at institute campus on 24.09.2021 from 1500 hrs onwards and all students has to reach institute by 1000 hrs 25.09.2021. The stay of these students has been restricted prospective only 30 days view to recall GP 1 soon for the remaining Practical.

GP 3 (GP 06/2021) course students are to carry their toiletry item, undergarments, night suits, bathroom chappals, Saving kit, sanitizers etc , books, note books, uniform, linen, etc shall be issued on arrival on 26.09.2021 {Sunday between 0930-1230 hrs}.

The likely departure of yours for next online/BST course shall be 23.10.2021.

Students are hereby informed that the entry shall be permitted to a students on present a RT-PCT Negative test report undertaken in last 72 hrs before reporting to this institute.

No any kind, type reason, circumstances leave is permitted to any student during the above training period. In case any emergency, we may leave the students however the re entry is permitted with negative RT PCR Test report.

The training shall be conducted as per the Daily routine issued under Joining Instructions issued at time of admission in course.

Ensure have proper haircuts, no beard, machetes, have been done. No such facility shall be provided in campus.

Stock of sanitizers, handkerchief, set of masks is mandatory to carry and use on daily basis.

Use of mobile phone is strictly for usage in the hostel/room only. In case any student found having or using mobile phone in musters, messes, sport ground, library or alleyways shall be punished according to the SIMS Order and mobile shall be impounded.

Incase any student is due/submitted lesser amount of fee, kindly bring with you and submit to the accountant only on arrival.

Individual is responsible for his belonging, valuables at all times, keep your locker/almirah etc locked :Charging a mobile even in accommodation in absentee is not permitted.

Students found talking in local language, abuses or dis- obedient, shall be sent back to home and no further entry is permitted.

100% attendance is needed to permit you in All India exit examination {Final Exam}

Students found not obeying covid protocol shall be suspended from the course for next 06 months and no entry in institute campus.

The final installment of course fees: Students are due to make payment of final installment of course fees, hence all are advised to bring the remaining course fees or the same can be submitted in the account of this institute.

Security deposit: Students to carry security deposit of INR 5,000/- (five thousand only) if you have not deposited at time of admission.

Usage of mobiles: Strictly in hostel/ wards only fine INR 10,000 (ten thousand only) if found using other than above
