Re commence of Pre sea Training in DGS Approved MTIs training from 26.10.20 as directives /Guidelines issued vide DGS Order no 32/ Of 2021 dated 22.10.2021

Trust all are safe with your family, friend near and dears. We have just passed through a tuff time bearing the 2nd wave of pandemic covid 19. Understand the difficulties faced by one and all. The imposing of curfew/lockdown by the Govt. of NCT Delhi steered us to directed you all at a course to home after counselling/submission of original documents.

As the situation is improving and the DGS has now permitted approved MTI with 100% occupancy effective from 26.10.021. The institute has to conduct the training as per the very best directives and guidelines of the DG Shipping, Ministry of Ports and Shipping. All approved course has to be streamlined so as to ensure the timely completion of training, assessment and certification. These order shall come into force ensuring proper implement of SoPs issued by the DGS and Govt. of NCT Delhi.

Faculty/instructor attendance: All full time faculty and instructors involved in Pre Sea Courses shall remain available to impart the Practical training to the students in campus. Effective from 01.10.2021. faculty and instructors in their tenure in cam[us for the practical training shall ensure the social distancing, wearing of masks, washing of hands and sanitizing of man, material, equipment offices and accommodation including messes and dining hall.

Requirement of RT PCR Test/covid Vaccination: Students are encouraged to complete their 2nd dose of the covid vaccination prior to arrive. In case you have not completed 2nd dose or no dose, kindly ensure you are in possession of RT PCR Negative test report issued by an ICMR approved lab/ Govt. dispensary performed within 72 hours of joining institute. Antigen report shall not be accepted. The duty instructor/warden shall be receiving students in his office along with declaration form and a letter from their parents confirming their agreement to attend training in institute's campus and his ward shall abide by all covid rules/protocol.

Wellness certificate: All students are hereby informed to submit a wellness certificate duly signed by them at the time of reporting for training.

Schedule of reporting of courses/Students: All students as per the schedule below shall reach institute for Practical training/ external examination. Note that the last notice on subject issued by the undersigned 18 of 2021 {Last para} dated 14.10.2021 stand cancelled in respect of reporting of GP Rating course 1 for practical as now all students of GP Rating and cadets shall report on 30.10.2021 for course in institute view of DGS now permitted 100% occupancy in respect of Pre sea courses.


