Mandatory Copy {Soft/Hard} of Seaman Identity Document{SID}: Note that all course participants attending Part B courses are in possession of Seafarer Identity Document. In case you have applied SID and approved, allowed to attend course. No entry in courses without SID

Instructions to the course participants: All officers / crew making Online booking of any Part B course are hereby directed that this institute has not conducted part A course for any course on or after 01.04.2022, hence not to book any Part B course if you have attended any course of Part A on or after 01.04.2022. Custodian of valid certificate {Part A} {attended part A before 31.03.2022} will be accommodated in any part B courses. Participants are to ensure that:

- {a} He is in possession of valid Part A Certificate from DGS approved MTI and Have Copy of Seafarers Identity Document {SID} or BSID generated
- {b} Participant to have valid Medical fitness certificate issued by an approved doctor by the DGS.
 - {c} Applicant have completed both vaccination of Corona mandatorily.
 - {d} Submit wellness certificate on arrival in institute.

Holidays: Institute shall observed holidays if declared by the DGS/Central Govt of India. Course schedule shall be postponed on next day.

Important: In Part B courses participants once uploaded on the Batch details under E Governance of the DGS and Unable to attend he course by any reasons, shall not be allowed to attend a course {Part-B} anywhere in DGS approved MTI in India till an approval is obtained by the institute from the DGS.
